STRUCTURE, GOVERNANCE AND MANAGEMENT

Constitution

The Trust is a Scottish Charitable Incorporated Organisation (SCIO). It was registered in its current legal form on 18 May 2016, having previously been a company limited by guarantee (no SC16377). It has a single tier structure and as such the trustees are members of the charity.

Appointment of Trustees

The board, which normally meets several times each year, are the charity's trustees.

Membership of the board is open to all members.

Trustees are elected at the annual general meeting, and the board has the power to co-opt other trustees. There must be a minimum of 5 and a maximum of 10 trustees.

OBJECTIVES AND ACTIVITIES

Charitable Purposes and Activities

The Trustees of the Helensburgh Heritage Trust continue to promote the objects of the Trust in a variety of ways and to build on the successes of previous years.

The Aims and Objects of the Trust are:

- Education of the public
- Preservation, restoration and enhancement of objects of local interest
- Promoting a wider appreciation of the heritage and history of the area.

To enable the Trust to fulfil its Objectives the Trustees meet regularly throughout the year to consider matters ranging from the stewardship of the Trust's finances and assets, the provision of a winter programme of speakers on a range of subjects, to the provision of visual displays highlighting aspects of local culture and heritage.

The Trust holds and maintains a wide collection of documents and artefacts, which are catalogued and stored in suitable lock-fast premises in Helensburgh Parish Church. Because of structural problems, the Trust has been asked to vacate this store, but finding new premises is proving extremely difficult.

For the most part documents and articles in the Trust's care have been donated or loaned to the Trust (appropriately recorded) while from time to time purchases are made of items which become available. Potential purchases are always discussed and agreed by Trustees in advance and funds are designated for such opportunities.

CHAIRMAN'S REPORT 2025

As autumn approaches, it is once again time to reflect on the work of the Trust over the past year. I do so with both sadness and optimism.

First, with deep sadness, we mark the passing of our long-standing Trustee, **Alistair McIntyre**, who died suddenly in July. Alistair's contribution to the Trust, and to so many organisations in the town, was immense. His knowledge, enthusiasm, and good humour will be sorely missed, not only within the Trust but across the wider community. One of his final duties was helping us assess premises at Garelochhead Station as potential storage for our collection of artefacts and documents. True to form, he enlivened the visit with stories of the station and local rail travel — a reminder of how much of our local heritage he carried with him. For several reasons, Alistair's funeral has not yet taken place. Once that has been done, there is a hope shared with many of Alistair's friends, that a suitable memorial service or event can be arranged.

Turning to our activities, the **Winter Talks Series** once again proved popular, attracting healthy audiences and generous donations. We are a charity and these donations help us greatly with the hire of the hall and our other work. We are delighted to launch this year's programme on Wednesday 24 September with Stewart Noble speaking on the life of John

Logie Baird, with an eye on the forthcoming centenary of his invention of television in October 1925.

Our plans for an **interactive display of the Baird Televisor and receiver** had to be put on hold after Storm Éowyn landed on 24th January. It left the new Leisure Centre with a badly damaged roof, forcing the library into service as a temporary gym. As Robert Burns, whose birthday we celebrated the following day, reminds us, *"the best laid schemes o" mice an' men gang aft agley."* We remain hopeful that these historically significant items will find a home in the Civic Centre in time for the Baird Centenary celebrations in 2025-26.

We are pleased that the majority of our members are now on the 'GoCardless' scheme to pay their subscriptions. This allows the Trust to collect via a system similar to a direct debit rather than a standing order. There were some teething problems but once these are resolved it is a greatly simplified and time-saving process. We still cater for those who wish to pay by cheque or standing order.

Online, **Helensburgh Memories**, our Facebook group, continues to thrive and is edging towards 10,000 members. We were especially pleased that one of our regular photographic contributors, **Charlie McGinn**, created a 2025 calendar which raised an impressive £1,215 for the Helensburgh and Lomond Food Bank.

There remain some challenges. Negotiations continue with ScotRail over the potential use of Garelochhead Station for storage, and improvements to our website are still needed.

Our search for new Trustees is ongoing, and I am delighted to welcome **Deborah Hamilton**. She was co-opted as a trustee in August 2024, and this was ratified at our AGM 2 months later. Finally, I want to thank all of you for your continued membership, encouragement, and interest in the heritage of our area. Your support ensures that the work of the Trust not only continues but grows in strength.
